

I found out that humor gets students to listen, improves their understanding and reduces status differences between us. In 2016, I started to provide classes in English for Erasmus students. During workshops they are encouraged to present contemporary economic problems and solutions to them, using more innovative tools than an essay. Scientific Interest

My research interests are mainly focused on creating and developing the concept of a completely market-based health care system – without state interventions. I also deal with issues related to the so-called "market failures". Part of my work is also devoted to the analysis of public systems functioning in individual countries. Late 2020, I completed my PhD dissertation on US healthcare from the perspective of the Austrian School of Economics. Preparations are currently underway to submit a doctoral dissertation at my university. I try to conduct my research from the perspective of the Austrian school of economics, which has a very solid theoretical output describing and explaining the functioning of many aspects of the market economy (e.g. money, prices, interest rate or capital). There remains, however, a certain open gap relating to the concept of a market-based health system and its individual elements – including health insurance. Its completion, at least partially, will allow for a better understanding of the concepts leading to a greater marketization of health care.
